## GENERAL TERMS AND CONDITIONS

General Terms and Conditions BETA TESTER Bitcoin.co.id (hereinafter referred to as “Terms and Conditions”) is a provision that contains terms and conditions regarding the use of products, services, technology, and features in the BETA TESTER testing program provided by Bitcoin.co.id includes, but is not limited to the use of the Website (hereinafter referred to as the “bitcoin.co.id Website”) as long as it is not specifically regulated as stated in the Bitcoin.co.id account registration section which is made on the day and date stated in the registration section <https://bitcoin.co.id> account, is an integral and inseparable part of this terms and condition. By registering as a Tester, you declare that you have READ, UNDERSTAND, AGREE and COMPLY with the Terms and Conditions below. You are advised to read all terms and conditions carefully before using the bitcoin.co.id platform service or any services provided, and hereby you agree and bind yourself to all activities in this terms and conditions with the following terms and conditions:

### **Definition**

As long as the context of the sentence does not specify anything else, the terms or definitions in the Terms and Conditions have the following meanings:

1. **Website** refers to the online site with the address <https://bitcoin.co.id>. This website is managed by bitcoin.co.id, with not limited to the owners, investors, employees and parties related to bitcoin.co.id. Depending on the context, “Website” may also refer to services, products, sites, content or other services provided by bitcoin.co.id.
2. **Beta Tester** is user testing by end users to validate the usability, functionality, compatibility, and reliability tests of the software created.
3. **Crypto Assets** are crypto commodities that use the principle of decentralized technology based on a peer-to-peer network (interface) or known as a Blockchain Network that is traded on the platform.
4. **Blockchain** is an open distributed ledger that can record transactions between two parties efficiently and in a permanently verifiable manner.
5. **Member** is a person (individual), business entity, or legal entity that has registered on the bitcoin.co.id platform, thus obtaining authorization from the bitcoin.co.id platform to carry out Crypto Assets trading activities.
6. **Registration** is the process of registering to become a Tester on the bitcoin.co.id platform which is the initial process to obtain the latest platform services that have not been published to the public.
7. **Selection** is a series of stages for selecting members of the bitcoin.co.id platform to become a Tester through the Beta Tester testing program.

8. **Selected Tester** is a Tester who has gone through and completed the Selection stage carried out by bitcoin.co.id which will be emailed by bitcoin.co.id, and has the authority to test bitcoin.co.id features through the Beta Tester testing program.
9. **Tester** is a Verified Member on the bitcoin.co.id platform, so you have the opportunity to make a selection for testing on the bitcoin.co.id platform in the Beta Tester testing program.
10. **Feedback for Developers** is a statement including but not limited to criticism and suggestions given by the Tester, which can only be seen by bitcoin.co.id.

### **MEMBER REGISTRATION/REGISTRATION PROCESS TO BECOME A MEMBER INFORMATION AND DATA TESTER**

1. The requirements to become a tester are:
  - Verified Member on the bitcoin.co.id platform;
  - Agree to abide by these General Terms and Conditions;
2. For each registration process, if needed, the prospective Tester must show all and every data in accordance with his/her identity in the form of:
  - Name (according to the attached ID);
  - Home address (according to the attached ID);
  - Current residential address;
  - Telephone or mobile number (number must be active and used personally);
  - Place and date of birth (according to the attached ID);
  - Citizenship;
  - Gender;
  - Photo of a valid ID card. The identity cards that can be used are: Indonesian Citizenship Card (KTP), Driving Licence (SIM), Passport, Limited Stay Permit Card (KITAS), and Permanent Stay Permit Card (KITAP);
  - Profession;
  - E-mail (must be an active E-mail);
  - Verified Member account name.
3. And/or everything that is requested and required in relation to the specified registration requirements, and the prospective Tester hereby declares and guarantees that any data/information/documents/information/statements provided in connection with the registration process as a Bitcoin.co.id Tester are complete, original, correct and in accordance with the actual situation and is the latest data/information/document/information/statement that has not been/has not been changed and is still valid/not expired and not/no changes have been made.
4. Tester hereby agrees that the process of becoming a bitcoin.co.id Tester will only be effective after the selection process and all bitcoin.co.id requirements are met by a Verified Member and approved by bitcoin.co.id. All risks that arise in connection with closing/blocking/freezing the Account caused by the error and/or negligence of the Tester, will be the responsibility of the Tester and bitcoin.co.id

will not provide compensation to the Tester or any party in any form for any claims/ claims and damages from the Tester or any Party in connection with the closure of the Tester Account.

5. All data, descriptions, information, statements, documents obtained by Bitcoin.co.id regarding the Tester, will become the property of Bitcoin.co.id and Bitcoin.co.id has the right to verify, match, assess, keep confidential or use it for the benefit of Bitcoin.co.id in accordance with applicable legal provisions without Bitcoin.co.id's obligation to notify or request approval, provide guarantees or compensation and for any reason to the Tester.
6. Bitcoin.co.id will regulate, manage and supervise according to the procedures/procedures set by Bitcoin.co.id for all data, information, information, statements, documents or anything related to the Tester or the Tester's business activities or transactions related with the Tester Account.
7. Tester hereby grants approval and authorization to Bitcoin.co.id to use all data, and information obtained by Bitcoin.co.id regarding the Tester including but not limited to the use of the Tester's personal means of communication for all other purposes to the extent permitted and permitted by law. – Applicable invitations, including those aimed at marketing for Bitcoin.co.id or for other parties collaborating with Bitcoin.co.id. For the use of data that requires the approval of another party, Tester hereby declares that it has given written consent to any Third Party for the use of such data, information and information, and therefore Bitcoin.co.id hereby will not provide compensation and/or liability in any form to the Tester and any party for all risks, demands, claims and/or compensation that may arise in the future in connection with the use of data, information and information that has obtained the written approval by Bitcoin.co.id.

## **PROHIBITION**

Without prejudice to the provisions regarding the prohibitions contained in this Terms and Conditions, the Tester is prohibited from doing the following case:

1. Testers are not allowed to take actions that can cause losses for Bitcoin.co.id and or that are contrary to the Terms and Conditions and the applicable laws and regulations.
2. All things including but not limited to data, features, services obtained by the Tester from Bitcoin.co.id including but not limited to those relating to the Beta Tester Testing Program must be kept confidential by the Tester and not used for any purpose without the written consent of Bitcoin.co.id.
3. If found to have violated one or more of the provisions in these Terms and Conditions, the Tester will be fully responsible and hereby agrees that for the violation Bitcoin.co.id has the right to limit the features of using the Bitcoin.co.id service and the Tester acknowledges and agrees that Bitcoin.co.id will not provide compensation and or liability in any form to the Tester or any party for any risks or consequences arising from restrictions on the use of these services. The tester is then obliged to pay compensation to Bitcoin.co.id in the amount of the loss suffered by Bitcoin.co.id for the violation. The Tester hereby authorizes

Bitcoin.co.id to debit the Tester Account for the payment of the compensation. In the event that the funds in the Tester Account are not available and or insufficient, then the Member must return all the funds in cash to Bitcoin.co.id within 7 (seven) working days after Bitcoin.co.id submits a claim.

## **CONFIDENTIALITY**

During cooperation with Bitcoin.co.id and at any time thereafter, then:

1. Any information and or data provided by Bitcoin.co.id to the Tester and or data obtained by the Tester as the implementation of the Terms and Conditions either given or delivered orally, in writing, graphically or delivered through electronic media or information and or data in other forms during the course of the conversation or while other work is confidential (hereinafter referred to as “**Confidential Information**”).
2. The Tester agrees and agrees that at all times he will keep confidential information obtained as a result of the cooperation with anyone or will not use it for the benefit of the Tester or the interests of other parties, without first obtaining written approval from the authorized official from Bitcoin.co.id or the party who other authorities in accordance with applicable legal provisions.
3. If the Tester violates the provisions as referred to in points 1 and 2 of the provisions regarding this confidentiality, then all losses, demands and or claims experienced by Bitcoin.co.id are the full responsibility of the Tester, and at the first request from Bitcoin.co.id, the Tester is obliged to resolve it in accordance with the provisions of applicable laws and regulations and provide compensation that may arise as a result of the violation to Bitcoin.co.id. The Tester hereby agrees that Bitcoin.co.id will not provide compensation and or liability in any form to the Tester or any party for any claims and or lawsuits that may arise in the future in connection with the violation.
4. The obligation to keep confidential information as referred to in points 1 and 2 provisions regarding confidentiality becomes invalid, if:
  - Such confidential information becomes available to the general public.
  - Such confidential information is ordered to be disclosed in compliance with an order by a court or other competent government agency.
  - Such confidential information is provided in accordance with applicable laws.
5. The Tester further agrees to make every effort and take every necessary action to prevent third parties from gaining access to or resulting in the disclosure of confidential information.
6. In the event that the Beta Tester Testing Cooperation has ended, the Tester agrees that the obligation to keep documents and materials that constitute confidential information as regulated in this provision will still apply.

## **NEGLIGENCE**

1. The Tester agrees that what is meant by Negligence (Default) is the following matters or events:
  1. Negligence (Default).

2. If the Tester is negligent in carrying out an obligation or violates a provision in the Terms and Conditions.
  3. Statement Not True.
  4. If it turns out that a statement or guarantee given by the Tester in the Terms and Conditions - is not true or does not match the reality.
2. In the event of an incident of negligence based on number 1 of the provisions of this negligence by the Tester, Bitcoin.co.id can choose whether to continue or close the Tester Account. If Bitcoin.co.id wishes to close the Tester Account, then the intention must be notified to the Tester within a reasonable time according to Bitcoin.co.id.
  3. In the event of negligence by the Tester as intended, Bitcoin.co.id.com has the right to immediately deactivate the Tester Account on Bitcoin.co.id without having to give prior notification to the Tester, and the Tester hereby agrees that Bitcoin.co. id will not provide compensation and or liability in any form to the Tester or any party for any claims and or claims and or claims and or requests for compensation from any party that may arise in connection with the occurrence of such negligence.

## **INTELLECTUAL PROPERTY RIGHTS**

1. Tester acknowledges and agrees to Bitcoin.co.id as the holder of ownership rights to services, software, technological tools and content, sites, and other materials including Intellectual Property Rights related to bitcoin.co.id facilities.
2. Testers are only allowed to view, print and/or download copies of materials from the Website for personal and non-commercial use. All commercial use requires permission from Bitcoin.co.id. Any commercial activity without Bitcoin.co.id's permission is defined as a violation of Bitcoin.co.id's Intellectual Property Rights and results in the termination of the Bitcoin.co.id Account on the Tester.

## **FORCE MAJEURE**

1. What is meant by Force Majeure are events that occur beyond the ability and power of Bitcoin.co.id so that it affects the implementation of transactions, including but not limited to:
  1. Earthquakes, hurricanes, floods, landslides, volcanic eruptions and other natural disasters;
  2. War, demonstrations, riots, terrorism, sabotage, embargoes, and mass strikes;
  3. Pandemics, epidemics and other national disasters;
  4. Economic policies from the Government that directly influence;
2. As long as Bitcoin.co.id has carried out all of its obligations in accordance with the applicable laws and regulations in connection with the occurrence of the Force Majeure, Bitcoin.co.id will not provide compensation and or liability in any form to the Tester or any other party for any any risks, responsibilities and claims that may arise in connection with the delay or non-performance of obligations due to Force Majeure.

## **ANNOUNCEMENT**

1. The Tester agrees to communicate with Bitcoin.co.id in an electronic format, and agrees that all terms, conditions, agreements, notices, disclosures or any other form of communication provided by Bitcoin.co.id to the Tester electronically shall be deemed to be in writing.
2. Tester agrees to receive emails from the Website. E-mails sent may contain information about accounts, transactions, systems, promotions and so on which are the latest versions of the Bitcoin.co.id platform.

## **DISPUTE RESOLUTION**

Any dispute, dispute or difference of opinion (hereinafter referred to as "**Disputes**") arising in connection with the implementation of the cooperation will be resolved in the following manner:

1. That every Dispute, to the extent possible, will be resolved by way of deliberation to reach consensus.
2. Any Disputes that cannot be resolved amicably will be resolved through the Central Jakarta District Court.

## **LEGAL DOMICILE**

SKUs are created, interpreted and enforced based on the laws of the Republic of Indonesia. Bitcoin.co.id.com and Tester have agreed to choose a common and unchanged legal residence at the Registrar's Office of the Central Jakarta District Court.

## **OTHERS**

1. This SKU is subject to and enforced based on Law No. 8 of 2010 concerning the Crime of Money Laundering and the Regulation of the Head of PPATK [PER-09/1.02.2/PPATK/09/12](#), No. [PER-12/1.02/PPATK/06/13](#), [No. PER-12/1.02.1/PPATK/09/11](#) and [No. PER-02/1.02/PPATK/02/2014](#) . Therefore, all transactions with a nominal value above Rp. 100,000,000,- (one hundred million rupiah) are required to report the transaction to the PPATK.
2. For matters that have not been regulated in these Terms and Conditions, all provisions in the Civil Code as well as the provisions of other relevant laws and regulations will apply.
3. If Bitcoin.co.id makes changes to the contents of this Terms and Conditions, Bitcoin.co.id will notify the Tester of the changes in accordance with the applicable laws and regulations through notification media that Bitcoin.co.id deems good and then the Tester will be subject to the changes.
